## **Peddler, Solicitor and Canvasser Permit**

This Permit No. 2014: \_\_\_\_\_ is issued to \_\_\_\_\_ by the Town of Platteville, Colorado pursuant to Article VII of Chapter 6 of the Platteville Municipal Code (the "Code"), said Permit to expire on December 31, 2014. This Permit relies upon and specifically incorporates the representations indicated in the Peddler, Solicitor and Canvasser License Application completed by the Applicant.

The holder of this Permit understands and agrees that pursuant to Section 6-7-90 of the Code, he shall retain in his possession the Permit and identification card issued by the Town Manager at all times when engaged in the business of peddling, or when engaged in the activity of soliciting or canvassing within the Town.

The Permit holder also understands that pursuant to Section 6-7-130 of the Code, peddling, soliciting, or canvassing is unlawful where a "No Peddlers or Solicitors" sign, or words of similar import, is posted.

Pursuant to Section 6-7-140 of the Code, it is the responsibility of each peddler, solicitor and canvasser who enters the Town for purposes of peddling, soliciting, or canvassing to obtain a copy of the current "No Visit List."

The holder of this Permit understands and certifies that he/she will directly supervise and accept responsibility for any persons acting under this Permit. S/he understands and agrees that any action taken by any person under this Permit in violation of Article VII of Chapter 6 of the Code or the terms and conditions of this Permit shall be imputed to the Permit holder and constitutes immediate grounds for revocation of this Permit. The holder of this Permit further certifies that any persons who are permitted to act pursuant to the Permit meet the qualifications set forth in Section 6-7-80.
